## **ANNOUNCEMENT POWER GENERATION FOR OCTOBER 2024**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited\* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation for October 2024 on a consolidated basis amounted to 5,897,268 MWh, representing a year-on-year increase of 8.22% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 24.35%, and other renewable energy power generation registered an increase of 67.68%. As of 31 October 2024, the total power generation of the Company for 2024 amounted to 62,743,860 MWh, representing a year-on-year increase of 2.94% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 0.44%, and other renewable energy power generation registered an increase of 81.12%.
