ANNOUNCEMENT POWER GENERATION FOR JANUARY 2025

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The new energy power generation of China Longyuan Power Group Corporation Limited* (the “**Company**”) for January 2025 on a consolidated basis amounted to 6,392,192 MWh, representing a year-on-year decrease of 8.56% as compared with the corresponding period of 2024, mainly due to the fact that the Company ceased to own coal power consolidated installed capacity from October 2024 and no coal power generation was generated during the month. During the month, the wind power generation registered an increase of 2.37%, and PV power generation registered an increase of 47.18%.

Details of the power generation of the Group for January 2025 are set out as follows:
